

## GUIDELINES FOR AUTHORS

*Journal of Taxation and Regulation of Financial Institutions* publishes articles of interest to the financial services industries and advisors to those industries. Most articles deal with tax and regulatory issues, but some articles cover topics that are of broader interest to the financial community. Articles are generally practical, but theoretical discussions are sometimes appropriate. For instance, the Journal has included articles that discuss the possible tax treatment of new financial products. The publication is in English only, but articles have been written by authors in many countries. Although most of the law covered by the Journal is U.S. tax and regulatory law, there is considerable interest in the law of major U.S. trading partners and the Journal appreciates submissions dealing with the law of other countries and with cross-jurisdictional regulatory issues.

Your submission of a manuscript clearly implies a commitment to publish in the *Journal*. Articles are subject to editorial revision. Papers under review by other journals or previously copyrighted by other publishers are unacceptable. Articles adapted from book-length works in progress will be considered under acceptable copyright arrangements. Except in rare cases where alternate arrangements are made with an author, copyright is retained by the publisher on all published articles.

There are no charges for publishing in the *Journal*. Authors receive no compensation for submission but, publication runs permitting, will receive five copies of the *Journal* issue in which their articles appear.

**Manuscript Specifications:** Submissions should not exceed 40 typewritten, double-spaced pages. Manuscript should be submitted electronically in Microsoft Word or Rich Text Format if possible, or in a format readily convertible to Word. Any tables, graphs, or figures should be placed on separate pages and must be submitted in black and white only; figures that are not available in Microsoft Word, Excel or Rich Text Format may be submitted as PDF documents.

Citations and references should be included in footnotes. Authors are encouraged to use Blue Book style in submitting articles, but any complete citation format will be acceptable if it allows the editors to put references in specific *Journal* style. When citing to online resources, please include specific webpage locations for materials. For lengthy posted materials, references should indicate how the cited materials can be found inside the posting. If a webpage reference is to a website that is constantly updated, with archived material moved to other portions of the website, or deleted after a specific time, the reference should indicate when the posting was last viewed by the author.

**Required Author Contact Information:** Please also include a brief biographical note for each bylined author, along with postal, email, and telephone contact information. Because of the Journal's policy of publishing articles in a timely manner, any editorial questions will be sent by e-mail or will be the subject of a telephone call. If the article is accepted for publication, author copies of the *Journal* issue in which the article appears will be sent to the author's physical address.
